#### **General Information**

- 1. This flower show conforms to the standards established by National Garden Clubs, Inc. (NCG). The Handbook for Flower Shows (FSHB), 2017 Edition, with revisions printed in the National Gardener magazine (TNG), is the authority for all issues not covered by the schedule, which is the law of the show.
- 2. Dates and times for all Entries and Exhibits are as follows:
- 3. **Any** amateur gardener may enter *Horticulture* in this show. Horticulture specified and all Design entries must be pre-registered.
- 4. Garden Club Members' entries will be accepted as *received*. Design classes will be closed when filled. Please check with the Consultant listed for specifics.
- 5. Each exhibit must be checked through the Classification and Inspection Committees prior to the Exhibitor leaving the show area.
- 6. **No** artificial plant material allowed. All entries must contain plant material as specified by the schedule. Plant material will be either fresh, dried, or a combination of both as required by the class description.
- 7. All exhibits must be kept in show condition i.e. unsightly or wilted plant material must be replaced.
- 8. Exhibitors will be responsible for watering their entries and exhibits.
- 9. No entries may be removed prior to 5:00 pm on Sunday, March 15, 2020.
- 10. District IIB will strive to ensure the safety of all items after arrival and placement, but is not responsible for any lose or damage to exhibits.
- 11. The color of the background drapes will be teal.

# **Judging and Awards**

- 1. Judging will occur on: Thursday, March 12, beginning at 12:45 pm.
- 2. **No one** other than the Judges, Clerks, Classification Chair and Flower Show Chair will be permitted in the show area during judging. Exhibitors may *not* be present during this time.
- 3. Decisions of the Judges will be final and Exhibitors may not discuss exhibits with the Judges.
- 4. National Garden Club, Inc. accredited Flower Show Judges will judge all classes and sub-classes using the Standard System of Awarding as set forth by National Garden Clubs, Inc., as follows;
  - One Blue Ribbon must score 90 or above
  - One Red Ribbon must score 85 or above
  - One Yellow Ribbon must score 80 or above
  - One or more White Ribbon must score 75 or above
  - To win a National Garden Club Top Exhibitor's Award, a Blue Ribbon must score 95 or above.

NOTE: Ribbons are awarded only when merited and all ribbons may score higher than the minimum given.

5. All requirements for National Garden Clubs' Top Exhibitor Awards, as listed on pages 39-48 of the Handbook for Flower Shows (HBFS) must be met.

# Division I Horticulture Awards and General Requirements and Horticulture Rules

- 1. Exhibit must be a **Blue Ribbon Scoring 95** or above to win a National Garden Clubs, Inc. Top Exhibitor Award.
- 2. Exhibit must have proper binomial name according to the schedule.
- 3. An award must be withheld if none of the exhibits designated in the schedule meet specific requirements.
- 4. All Horticulture Classes are open to any amateur grower. All specimens must be fresh plant material grown by the Exhibitor. All Container Grown Plants must have been in the Exhibitor's possession for no fewer than 90 days. Combination plantings must have been grown together no fewer than six weeks.
- 5. When possible, entry tags need to be completed <u>in advance</u> with the <u>correct binomial name (genus and species)</u>. Variety and cultivar are encouraged. Common names may be added. Entry tags are available from Garden Club Presidents with additional tags available at the "Classification" table.
- 6. All entries and all entry tags must include Exhibitor's name, address and Club name (if applicable). Address labels are acceptable.
- 7. The Horticulture Placement Committee or Show Committee Chair may subdivide Classes by cultivar, type, or color.
- 8. Bottles for specimens **will be** provided. Cut specimens should not have any foliage or debris below the water line. Wedging is permitted and floral foam will be provided by the committee. Entries should be clean and must be free of insects. Oiling or shine treatment of foliage is NOT permitted.
- 9. An Exhibitor may make more than one entry per Class *only if* each exhibit is a different cultivar, type, or color.
- 10. Specimen with a class designation in the schedule may not be entered in the "any other worthy" class. House plants grown primarily for foliage are entered in Foliage Classes, even if a bloom is present.
- 11. All pots must be clean. Double potting is permitted in all Classes.
- 12. **All plant containers larger than 12" must be pre-registered** with Kathleen Denisi at (517) 339-2527 to ensure adequate display space.

(HBFS page 59). Combination Plantings must have been growing together and in exhibitor's possession for at least 6 weeks. **NOTE:** All plants in a container garden greater than 12 inches in diameter <u>must be pre-registered to allow for display space.</u>

# **Section E - Indoor Specialties"Winter Garden"** by Kristin Hannah

All plant material must be fresh and grown by the exhibitor. Exhibits that met **General & Horticultural Award** requirements are eligible for the **Grower's Choice Award**, (Section Award) a rosette of dark green ribbons. **NOTE:** All plants in a container garden greater than 12 inches in diameter must be pre-registered to allow for display space. For in-depth information on specific plants, refer to the *NCG Horticulture Exhibiting the Judging* Book.

#### "Garden in the Wind" by Gabrielle Roy

- All specimens must be fresh and show signs of forcing.
- All specimens must be at least 18" and not exceed 30" in overall length. Apical end must be present and specimen must have several nodes.
- Trees and shrubs are eligible; vines are not eligible.
- Staging will be provided. Bottle type containers will be furnished. No foliage is allowed below water line.
- Floral foam wedging will be provided by the committee.
- Class 21 Flowering Branches Examples: Forsythia, Apple and Mock Orange
- Class 22 Branches with Character Examples: Harry Lauder's Walking Stick, Winged Euonymus and Curly Willow
- Class 23 Broadleaf Evergreens Examples: Holly, Cotoneaster, Boxwood and Rhododendron
- Class 24 Deciduous Branches Evamples: Birch Manla and Oak

#### **Section G – Needled Evergreen**

Eligible for Arboreal Awards, (Section Awards), a rosette of two shades of green ribbon.

- Minimum of 5 different container-grown or cut flowers with 3"x 5" card stating the plant's relationship.
- Exhibited in individual containers, or give the appearance of individual containers.
- Staged on a table

#### Section I – Displays

- A collection of specimens **exhibited with a strong overall staged artistic effect.**
- Minimum of 5 different but related container-grown or cut flowers. Specimens must be related, such as all one plant family. (HBFS page 60)
- Cut specimen containers need not be clear nor identical.
- **Pre-registration required**. Staged on a 2' x 2' section of table with unlimited height.

## **Awards and General Requirements**

- 1. Exhibit must be a Blue Ribbon winner, either Creative or Traditional, scoring 95 or above to win a National Garden Clubs, Inc. Top Exhibitor Award.
- 2. Plant material need not be grown by the exhibitor.
- 3. There must be a minimum of 3 classes with at least 4 entries in each class.
- 4. No Section may be eligible for more than one top exhibitor Design Award.
- 5. The following awards are available only in Division II Design, if warranted.
  - **Designer's Choice Award**, (Section Award); Awarded to the highest scoring exhibit designated in the schedule. The designers may use their choice of materials and other components, (HBFS page 42).
  - **Petite Award**, (Section Award); Awarded to the highest scoring exhibit designated in the schedule. All plant material is fresh and/or dried in each Class, (HBFS page 43).
  - **District Directors' Award**, (Local Award); Awarded to a design that demonstrates a challenge to the Exhibitor.
  - Lois Snover-Hanson Award, (Local Award); Awarded to a design for excellence in mechanics.
  - **Special Awards**, (Local Award); Presented in recognition of the individual effort or contribution to the flower show. Winners are presented with a National Yellow Rosette.

#### **Design Rules**

- 1. All Classes are open to any Michigan Garden Clubs, Inc. member who is an amateur arranger.
- 2. A 3"x5" card, neatly typed or printed naming the plant materials used must accompany each entry tag and may include explanation of design. Though binomial names are not required, they are encouraged for educational purposes.
- 3. An Exhibitor may enter as many Classes as desired. But only one exhibit per Class or Subclass.
- 4. All design work must be the work of the Exhibitor. Plant material need not be grown by the Exhibitor.
- 5. **No** artificial flowers, fruit, or foliage is allowed. Fresh plant material must **never** be treated
- 6. Some plant material must be used in every design.
- 7. Religious symbols used must be displayed in a respectful manner and in accordance with local church policy.
- 8. All living members of the Animal Kingdom, e.g. mammals, birds, fish, etc., and taxidermal representation of the same, are not permitted in a Standard Flower Show.
- 9. The official American flag and other national flags are **not permitted** to be used within any design in a Standard Flower Show. The use of any national flags as an underlay, background, skirting, draping, etc. is also **prohibited** throughout all divisions of the Standard Flower Show.
- 10. Landscapes or scenes are not permitted in the Design Division.
- 11. Fruit and/or vegetables that are uncut may be used in Sections A, B, C and D.

**Note:** "Design Components" refers to those materials used when creating a Floral Design. It includes plant material (fresh and dried), featured objects, accessory objects, special staging (background, frames, etc.), and mechanics which are organized in a volume of space.

# **Spatial Thrust Design**

- Plant material and other optional components maybe added ONLY to the outer edges of the thrusting lines and along the bottom of the arrangement.

- 1. You must preregister with the designated consultant for each class entered.
- 2. If you are entering horticulture and/or design in this show, your entry photograph(s) must be entered in the show at the same time. Be sure to write your entry number on the entry tag for your photo.
- 3. Photos are to be entered without mats or frames. The staging committee will provide black mats and hang the entries.
- 4. Please complete entry cards in advance, if possible. Consultants will have entry cards available for your use.
- 5. All photographs must measure 8" x 10" and contain some horticulture. They may be printed in portrait or landscape mode.
- 6. You are encouraged to submit a 3' x 5' card with each entry identifying plant material (botanical names preferred). Information about your photo may also be included.
- 7. The following awards are available only in Division III Botanical Arts Photography;
  - Botanical Arts Photography Award (Section Award) (HBFS page 45)
  - Barb Ketchum Photography Award (Local Award)

# **Judging and General Rules for NGC Photography Exhibits**

- 1. Intended to stimulate garden/gardening interest, photographic abilities and NGC goals and objectives.
- 2. Schedule determines type of photography, exhibit, staging and number of entries per class.
- 3. All exhibits must relate to horticulture, gardening, design, or other NGC goals, objectives and/or initiatives (landscape, conservation, civic projects, preservation, ecology, environment, etc.).
- 4. Schedule determines the image size, and may provide class types such as monochrome, black and white, and/or color.
- 5. Image must be matted by the committee; no frames allowed.
- 6. Professional printing and matting is permitted.
- 7. Images should be displayed vertically at eye level if possible, for judging and viewing.
- 8. Exhibitors are encouraged to label photographed plant material, preferably with current scientific designation.
- 9. Photo may be enhanced by the exhibitor with cropping, filters, adjustments and/or darkroom techniques.

#### 10. Judging

- a. Judging panel of three (3) may consist of one (1) NGC Accredited Judge and two (2) recognized photography experts such as qualified photography judges, photography instructors, photography professionals or museum curators; or three (3) recognized photography experts.
- b. Exhibits are judged by the Photography Scale of Points
- 11. Not eligible for exhibiting credit.
- 12. Photos may be exhibited in either portrait or landscape mode.
